BREEDER RESPONSIBILITY

When hand delivered, we guarantee that your puppy will be healthy when you take possession. It is suggested that you have your **puppy examined by a veterinarian within 10 days of delivery**. We want you to be fully assured of your puppy's health.

BUYER RESPONSIBILITY

If your veterinarian finds your puppy to have chronic or serious health issues, we are obligated to give you a puppy from the next available litter (breeder's choice). If you do not take the puppy for examination within 10 days of delivery, this contract is void. Any claim to this must be made within the 10-day period allotted.

During the time between receiving your puppy and the completion of puppy shots (approx. 16 weeks), it is the buyer's responsibility to keep the puppy away from public places such as, but not limited to, pet stores, Puppy Kindergarten or parks. A puppy's immunity is not strong enough to be exposed to potentially deadly viruses (such as parvovirus) before the puppy vaccinations are completed.

The buyer is responsible to care for the dog as a companion pet with quality food, exercise, indoor living quarters, outside play area with reliable fencing and regular veterinarian care, including puppy immunizations and worming, when necessary. The buyer is responsible to keep the dog fit.

Should the buyer be unable to keep the dog and it is agreed upon between Buyer and Seller, Buyer may return the dog to the breeder in order to find a new home for the dog. Seller is not obligated to return any funds to Buyer if or when this happens.

BREEDER/BUYER CONTRACT AND HEALTH WARRANTY

GENETIC HEALTH WARRANTY

We provide a guarantee for 2 years against any serious genetic illness that hinders the dog's quality of life. The dog will be replaced at the breeder's sole discretion. Diagnoses may be needed by two veterinarians. Contact breeder for specific requirements. Owner will be responsible for shipping.

This contract applies to the original purchaser and does not transfer when ownership of the dog changes.

If an examining veterinarian should find the dog has been abused, subjected to trauma, or neglected, the guarantee is void. Buyer shall return signed contract to the breeder within 10 days of delivery of puppy. Failure to return signed contract will render contract void.

LIMITATIONS OF CONTRACT

Breeder is under no circumstances liable to the buyer or any third party for consequential, incidental, or special damages resulting from the dog or related to the dog.

Upon possession of the dog all veterinary care and its costs are the sole and exclusive responsibility of the buyer.

Buyer and Breeder agree that this document represents the entire Agreement between them and that no other representations have been made regarding warranty of the dog.
